Futurity 2010

General Rules for Futurity

1. NYSSHA Futurity Stake classes are open to any horse/pony/mini as long as it is nominated. Owners must be members of NYSSHA before they are nominated. Proof of membership must accompany the nomination form. Exhibitor must be member of NYSSHA.
2. If the nominated entry is sold the Futurity Stake committee must be notified in writing of the change in ownership. The new owners must be members of NYSSHA to participate in the Futurity Stake Class.
3. No Refund on Nomination fees. No entry will be shown until paid in full. There will be a \$30 charge for returned checks.
\$25 must be postmarked by June 1, 2010
\$25 must be postmarked by July 1, 2010
If any payment is missed, the payment is doubled
Deadline Late Nomination by 7a.m. July 17, 2010 \$125
(\$100 Nomination fee and \$25 office fee)
5. The decision of the judges will be final.
6. NYSSHA reserves the right to cancel any Futurity Class, without notice, at any time prior to the contest without liability. In this event all nomination fees will be returned.
7. Owner may nominate as many entries as desired.
8. Each division will be shown separately.
 - a. Western Pleasure Futurity Class (horses 2 and Over)
 - b. Hunter Under Saddle Futurity Class (horses 2 and over)
 - c. Saddle Seat Pleasure Futurity Class (horses 2 and over)
 - d. Miniature Horse Halter Futurity Class (miniature horses any age)
 - e. Pony in Hand Futurity Class
9. Payment Schedule as advertised on entry form
10. Late Fee as advertised on entry form.
11. NYSSHA will retain 10% of the entry fee.
12. Payback will be 6 or more entries 40% / 25% / 15% / 10% / 5% / 5% .
1-3 entries 50% / 30% / 20%
4 entries 44% / 27% / 17% / 12%
5 entries 41% / 26% / 16% / 11% / 6%
13. Must show under all 3 judges. Classes will be held at the following shows:
Rugmakers Riding Club , Sacandaga Saddle Club , NYSSHA Fall Round-Up.
